NATIONAL MATHEMATICS CONTEST 2025

TERMS AND CONDITION

1. Entry Rules

RAJIV GANDHI SCIENCE CENTRE (RGSC) is the Organiser for the National Mathematics Contest (NMC) 2025 and reserves the right to refuse any entry which in their opinion does not comply with these Terms or which contravenes the spirit of the contest. The organizers have absolute discretion to disqualify any entry, or vary, amend, supplement, or waive the terms of the contest at any time and participants agree that no liability shall attach itself to these organisations as a result thereof and that the exercise of such discretion shall not result in any compensation being payable or paid to any participant. It is a condition of entry that all rules are accepted as final, and that the participant agrees to abide by these terms. The contest is subject to change.

2. Eligibility

Participation in the NMC 2025 is reserved for students of Grade 9 or equivalent attending school in Mauritius. Only individual entries can be entered. A maximum of four (4) entries will be accepted per school.

3. Entries & Registration

Entry into the contest is free. Registration to participate in NMC 2025 can only be made through the RGSC by an educator or school representative and requires the submission of the applicant's name, address and contact details, the applicant's organisation name, name of each participant, and agreement to the full Terms and Conditions. 5. Contest Judging

The Organizers shall appoint the members of the panel that will judge the contest entries and the performance of the participants. All decisions made by the judging panel shall be final and binding.
